

TENDER REQUEST FOR LAUNCHES JUNE 2024

Contains tender requests for launches mainly in June 2024. A few launches with later launches have also been included. Please note that there are different deadlines for the offers. For a few launches, purchases for the fixed range will be made in combination with purchases for TSV/TST. More information about TSV/TST can be found in the introductory text of previously published tender requests for TSV.

Please observe that many in the tenders occurring requirements etc. are specified through clarifications and examples in the so-called Tenders quick guide which is published on the Suppliers' portal. Please make sure that the most recently updated version of the Tenders quick guide is used during completion/submission of offer.

Please note that the supplier who is to launch an organic product must be certified by a control body, ie it is not enough that the product is organically certified. This certificate must be sent to Systembolaget no later than in connection with the launch samples deadline. Suppliers who have sent in such a certificate in connection with the launch of another organic product do not need to send it in again, provided that the previously submitted certificate is still valid. You send both new and updated certificates to inkopssupport@systembolaget.se.

Special information about the purchase process for A-classed tenders

By significantly shortening the time between the submitted offer and the notice of purchase, the risk of discrepancies between the submitted offer and the actual facts decreases. For A-tenders the tender sample is submitted together with the offer in order to be tasted shortly after, after which a quality audit can be carried out on site. Below is a more detailed description of the process:

Sunday week 0	The tender request closes in the portal at 23:59:59
Monday week 1	Offer examination and request of samples, alternatively rejection of offer.
Tuesday week 1	Tender samples are submitted.
Wednesday week 1	Deadline tender samples at 16:00
Thursday/Friday week 1	Tender tasting, booking of quality audit with number one and two in the tasting. Information to number three.
Week 2	Quality audits on site followed by a possible purchase order.

Deadline for review to ASN

Systembolaget always welcomes a Supplier, who wants a decision from Systembolaget further motivated/explained, to contact Systembolaget. In addition, the Supplier always has the right to have a decision reviewed by the Alcohol Assortment Board (ASN).

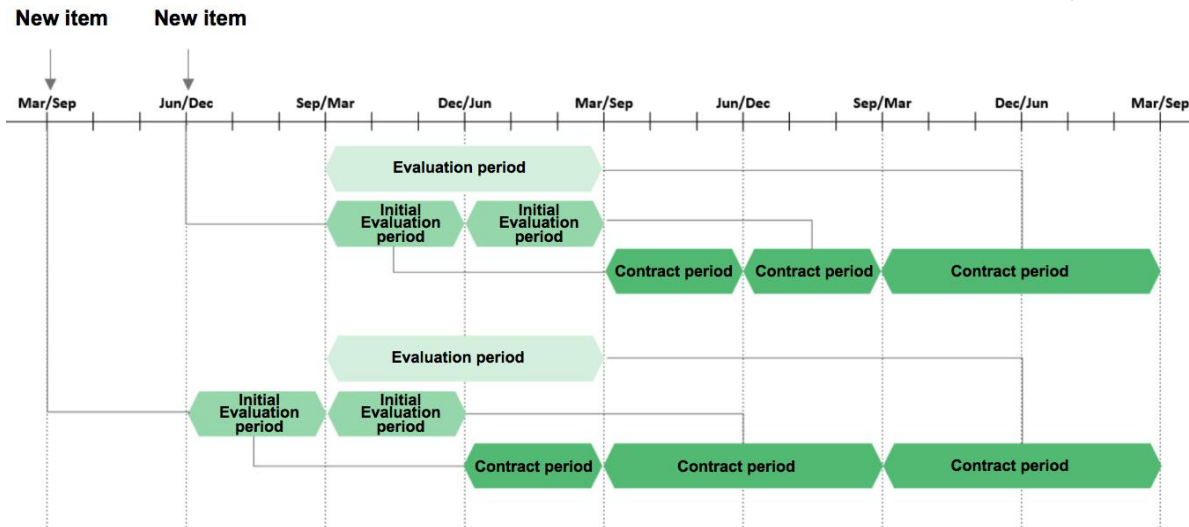
As previously announced on the portal, ASN now refers in one of its decisions to the Law of appeal of decisions by specific authorities with public administration duties, and the deadline that is stipulated as three weeks. ASN argues that the law does not contain any restriction to authorities with public administration duties and finds it applicable to Systembolaget's decision, in the absence of a different regulation in another law or constitution.

As a result of this decision, Systembolaget has entered this deadline in the general purchasing conditions of Systembolaget (Purchase Terms) from March 1, 2018. This means that any request for a review of a decision made by Systembolaget must be submitted to ASN within three (3) weeks from when the supplier received information about the decision. ASN is reviewing whether the appeal has been received in time.

Guaranteed contract period is nine (9) months

The first evaluation period for articles with launch date in June 2024 with the following ranking is from 2024-09-01 until 2024-11-30. All new articles have the possibility to, after evaluation and ranking, remain in the fixed range. If this is the case, the contract period is extended by three (3) months, to then be extended either for a further three (3) months (if the extension is from June 1st or December 1st) or for six (6) months (if the extension is from March 1st or September 1st). After that, the contract period can be extended by six (6) months at a time, depending on the result of the coming evaluation periods.

See below the scheme for news launches and evaluation periods.



Please note that for products that on launch day are organic and/or ethical, the guaranteed contract period is twelve (12) months, i.e. the first evaluation period starts six (6) months after launch.

Clarification of headers in the tender request and guidelines regarding how to fill in offers are published on the portal in the Tenders quick guide. We ask you in particular to note the following:

Distribution:

Each launch receives a distribution according to one or two range requirements, where the range requirement “Standard” includes store groups 1, 2 and 3, and the range requirement “Premium” corresponds to store groups 4 and 5. Within each range requirement, the store size (A=smallest store, E=biggest store) that will have the article in its assortment, is specified. This means that, as an example, an article with distribution “Standard ABCD, Premium CD” will be put in the range of all stores within store groups 1, 2 and 3, and the stores of the sizes C and D within store groups 4 and 5. The distribution is also given as market coverage (MT) and number of stores (AB) within brackets, as they were given in the launch plan where the launch was first announced. Market coverage is an indication of how big a part of the total sales of the segment a certain shop distribution represents (the market coverage varies from segment to segment since all segments don’t have the same sales in all stores). We ask you to note that the given figures for market coverage and number of stores must not be understood as a guarantee or similar, when it comes to how big distribution the requested product will have, since the conditions (sales patterns and/or the exact number of stores) can be different when the products that are now requested are launched.

Available volume (liters):

The minimum volume, identical to the tender sample, that you as a supplier must have available to answer the request. Available volume is not a sales forecast, or the amount that is required to keep distribution or similar.

Price to consumer:

The prices in the tenders are shelf prices to consumers, i.e. sales prices. For products with cash refund for recycled product, the price to consumer is stated excluding refund. In the offer however, the price to Systembolaget must be stated.

Packaging:

For certain types of packaging, it is possible to offer equivalent or more environmentally friendly packaging provided that this is evaluated in the same segment as follows:

If a glass bottle is requested, it is always possible to offer a PET bottle or paper packaging in bottle format (eg Frugalpac).

If PET bottles are requested, it is always possible to offer paper packaging in bottle format (eg Frugalpac).

If Bag-in-Box is requested, it is always possible to offer a pouch.

Note that the reverse does not apply. For example, if a pouch is requested, it is not possible to offer a Bag-in-Box.

Sub-contractors:

For wine, it must be specified where the volumes come from if the whole volume offered is not vinified by the stated producer. Please state all sub-contractors. For sub-contracted beer and spirits production for example, it must be specified where the product receives its final character.

Guarantee of Supply:

In the case a Guarantee of Supply is requested, this must be completely filled out. Ignored or wrongly filled out fields lead to rejection of offer. The stated producer in the document Guarantee of Supply must be the same as the producer stated in the offer. Furthermore, the stated "Supplier" must be the supplier that offers to Systembolaget. In the Guarantee of Supply, the size of volume included in the offered wine per tank, must be clearly stated. Note that it is the volume, to be used for the offered wine that needs to be specified per tank. Each tank must also be specified with tank number. On page 2 of the form, a new line must therefore be used for each individual tank. If the lines are not enough, you can use the page 2 of the form in several copies. If barrels occur and they are of the same size, they can be written on the same row with a total volume, provided that the number of barrels and barrels size is shown. If barrels of different sizes are used, they must be separated and written on different lines. In this case, the barrel number, lot number or equivalent identification used by the producer must be indicated in the column "Tank number". Please see also "Quick reference guide Guarantee of Supply and Audit for A-rated offers" on the Suppliers' Portal. Please ensure Submitted Guarantee of Supply is based on the current version as specified in the applicable version of Purchase terms and conditions that can be find on the Suppliers' Portal. You will find Guarantee of Supply under the tab Documents under Tender/Tender requests. Usage of old, not actual versions will be declined.

Specific information about new requirements for mapping during launch:

In all launches of articles for the Fixed Assortment regardless of origin, the supplier must, in connection with the submission of the documents and samples required to be launched, also enter information about the product's supply chain. As recently informed, all sustainability-related information will be collected in the new Sustainability Platform from September 1st, 2019 (more information can be found on the Suppliers' Portal). Before the launch sample deadline, the information below must be available in the Sustainability Platform:

- Mapping of the product supply chain
- Any certificates

More information about the mapping process can be found on the Supplier Portal.

Other:

Offers:

Suppliers who wish to reply to tenders do so through the Suppliers' portal. Offers and attached documents must be submitted through the portal up until midnight (23:59) on offer deadline day.

Attached documents:

All documents and certificates that Systembolaget asks for (as for example Fairtrade and Fair for life certification) must be current and valid. Certificates that have been suspended or in any other way temporarily or permanently revoked, are not to be considered valid.

Tender samples:

The products are purchased based on their sensorial quality. Tender samples, launch samples and products delivered to the stores must therefore agree sensory. See the paragraph on quality assurance.

The tender samples must be:

- physically, chemically and biologically stable.
- treated in the same way as the final product is intended to be treated. For example, if the final product will be filtered, the tender sample must be filtered.
- blended in the same proportions and of the same components/ingredients as the final product.

The quality of our launches is followed up at four (4) different occasions according to the description below.

Tender samples:

- The winning sample is chosen through a sensorial blind tasting.
- The winning sample for the fixed range goes through a chemical analysis from which the results are used as a reference for any possible discrepancies later in the process.
- The tender sample is archived.

Extra tender samples

As a supplier of a winning tender sample to an A-classified launch, you must be prepared to send in extra tender samples within four (4) working days from notification of the results, in order to be considered for a purchase. This means that already at the submission of the tender samples, you must have access to extra samples according to the below:

- Wine two (2) pcs
- Sparkling wine two (2) pcs
- Wine & Sparkling wine in can four (4) pcs

Please see also "Tenders quick guide for tender samples" which is published on the Suppliers' portal.

Launch samples:

- Sensorial comparison to the tender style- and taste profile.
- Chemical analysis - secures that the sample fulfills the prevailing legal requirements.
- Packaging/presentation control: the packaging is controlled against the prevailing legal requirements, laws, rules and specific demands in the tender request.
- For A-classified tenders, a sensorial and chemical comparison will be made with the extra tender sample.

Sales sample:

- The shop sample is compared to the tender sample, all products are tested sensorially after delivery to the shop before day of launch.
- If a discrepancy is established, a more sophisticated sensorial analysis is carried out, a so called triangle test.
- If the discrepancy is confirmed through the triangle test, a comparative quality tasting is carried out.
- A chemical analysis is made to secure that the shop sample agrees with the tender sample.
- The sales sample is archived.

After control:

- Test after three (3) months.
- Sensorial and, if necessary, chemical analysis
- Test after three (3) months.
- For A-classified tenders an after control will be carried out every fourth week for six (6) months.
